This firm represents the Applicant regarding its application to the Rumson Planning Board for preliminary and final major site plan approval at the above referenced property.

The Applicant is proposing to construct multifamily residential housing, consisting of fourteen dwelling units located within six buildings, as more particularly described in the Project Proposal enclosed herein. The Applicant is not seeking any variance relief in connection with this application.

This application is being submitted in connection with a certain Settlement Agreement between the Borough of Rumson and the Applicant dated January 16, 2020 as part of the Borough’s affordable housing compliance litigation, In Re Borough of Rumson, Docket No. MON-L-2483-15. Pursuant to the terms of the Settlement Agreement, the Borough of Rumson adopted Ordinance 20-014 on December 15, 2020 to rezone the Property into the Rumson Road Housing District (RR), which permits the development of the Property with up to sixteen residential dwelling units.
