**1. To Watch and Listen to the Proceeding:**

**2. To be Heard by the Court on the Application**

Individuals who want to place their position in support of or in opposition to the application should take the following additional steps.

Members of the public intending to state their position on the application will be heard after evidence is presented to the court by the parties. This may be sometime during the day on June 15, 2020, or if the presentation of evidence does not conclude on that day, the matter will be continued on June 22, 2020. Please note, if the proceeding is completed on June 15, 2020, there will be no proceeding held on June 22, 2020. The court will indicate on the record, which is being broadcasted on the live stream on the New Courts website, when it is time for the public to be heard.

Watch/listen to the Fairness Hearing, as set forth above. When the court indicates that individuals who want to be heard should call in, call the following zoom specific telephone number, enter the meeting ID and password. Members of the public are **not**

permitted to attend the zoom proceeding via a personal zoom account with video capabilities. Members of the public are **only** permitted to dial in using a telephone.
