RULES AND REGULATIONS**

**CURRENT RAMP FEES**

**\$120.00 FOR YEARLY PERMIT**

**\$40.00 FOR KAYAKS, CANOES, SHELLS**

**\$60.00 FOR SENIOR CITIZENS 65+**

**(all ownership documents must be in senior's name)**

1. **USE OF THE RAMP FOR COMMERCIAL PURPOSES IS STRICTLY PROHIBITED.**
2. **PASSES FOR RAMP USE ARE AVAILABLE FOR PURCHASE AT THE BOROUGH HALL IN RUMSON, DIRECTLY WEST OF BOAT RAMP. BOROUGH HALL BUSINESS HOURS ARE 8:30 AM TO 4:30 PM, MONDAY THROUGH FRIDAY. PASSES ARE VALID FOR THE CALENDAR YEAR, JAN. 1 THROUGH DEC. 31, REGARDLESS OF PURCHASE DATE.**
3. **PASS FOR RAMP ACCESS MUST BE IN FULL VIEW, PREFERABLY ON THE DASH OR MIRROR OF YOUR VEHICLE. IF YOUR PASS IS NOT IN VIEW, YOU WILL RECEIVE A SUMMONS.**
4. **BOATS SHOULD BE UNTIED AND TIED IN DESIGNATED AREAS. THESE AREAS ARE CLEARLY IDENTIFIED BY SIGNS.**
5. **CLEAR RAMP AREA AS SOON AS POSSIBLE.**
6. **YOUR BOAT SHOULD NOT BE AT THE FLOAT AREA FOR MORE THAN 10 MINUTES.**
7. **PLEASE PULL BOAT AROUND TO LAUNCHING RAMP AS SOON AS SPACE BECOMES AVAILABLE.**
8. **IF YOUR BOAT IS IN NEED OF REPAIRS, TIE IT UP AT THE LAST FLOAT. PLEASE MAKE RAMP OFFICER OR RUMSON POLICE AWARE OF THE PROBLEM AND ASK PERMISSION TO TIE IT UP UNTIL ARRANGEMENTS CAN BE MADE TO MOVE VESSEL.**
9. **ANYONE DRIVING OVER 5 MPH WITHIN 50' OF THE SHORE WILL FORFEIT THEIR PERMIT AND BE GIVEN A SUMMONS.**
10. **JET SKIS AND WATER SCOOTERS ARE NOT PERMITTED IN DEAD END CREEKS.**
11. **JET SKIS AND WATER SCOOTERS CANNOT TRAVEL OVER 5 MPH IN BLACKPOINT CREEK AND ADJOINING CREEKS, OR ANYWHERE WITHIN 50' OF LAND.**
12. **COME IN SLOW - NO WAKE!!**
